Financial Aid is often a time-sensitive process. Below you will find a helpful breakdown of important dates and deadlines that you should keep in mind. It is important to stay on track with deadlines to ensure that you will receive the maximum amount of aid possible.

Entering students and continuing/returning students often have different deadlines for submitting materials, so please make sure that you are reviewing the appropriate table.

#### *Key Dates for Fall 2010 Entering Students*

o January 1, 2010	File your 2010-2011 FAFSA at <a href="http://www.fafsa.ed.gov">www.fafsa.ed.gov</a>
o April 1, 2010	Preferred receipt date of the 2010-2011 FAFSA
o June 1, 2010	Enrollment deadline for the TMS payment plan
o June 15, 2010	Fall 2010 semester bills are mailed
o July 1, 2010	Recommended date to apply for private loans
o August 1, 2010	Payment due to the Bursar for fall semester charges. Late payment will result in a \$250 fee.
o September 24, 2010	First round of refund checks for the fall semester

o January 1, 2010	File your 2010-2011 FAFSA at <a href="http://www.fafsa.ed.gov">www.fafsa.ed.gov</a>
o April 1, 2010	Preferred receipt date of the 2010-2011 FAFSA
o November 1, 2010	Enrollment deadline for the TMS payment plan
o November 8, 2010	Spring 2011 semester bills are mailed
o November 13, 2010	Recommended date to apply for private loans
o December 13, 2010	Payment due to the Bursar for spring semester charges (entering students only). Late payment will result in a \$250 fee.
o February 4, 2011	First round of refund checks issued for the spring semester

#### *Key Dates for Summer 2011 Entering Students*

o January 1, 2010	File your 2010-2011 FAFSA at <a href="http://www.fafsa.ed.gov">www.fafsa.ed.gov</a>
o March 15, 2011	Summer 2011 bills are mailed
o April 1, 2011	All students enrolling for summer 2011 should have the 2010-2011 FAFSA on file by this date.
o April 22, 2011	Payment due to the Bursar for summer semester charges. Late payment will result in a \$250 fee.
o June 10, 2011	First round of refund checks issued for the summer semester

○ April 1, 2010	Preferred receipt date of the 2010-2011 FAFSA
○ June 1, 2010	Enrollment deadline for the TMS payment plan
○ June 15, 2010	Fall 2010 semester bills are mailed
○ July 1, 2010	Recommended date to apply for private loans
○ August 1, 2010	Payment due to the Bursar for fall semester charges. Late payment will result in a \$250 fee.
○ September 24, 2010	First round of refund checks issued for the fall semester
○ November 1, 2010	Students graduating in December must complete Exit Interview requirements

○ January 7, 2011	Payment due to the Bursar for spring semester charges. Late payment will result in a \$250 fee.
○ February 4, 2011	First round of refund checks issued for the spring semester
○ May 1, 2011	Students graduating in May must complete Exit Interview requirements

### ***Key Dates for Summer 2011 Continuing Students***

○ January 1, 2010	File your 2010-2011 FAFSA at <a href="http://www.fafsa.ed.gov">www.fafsa.ed.gov</a>
○ April 1, 2011	All students enrolling for summer 2011 should have the 2010-2011 FAFSA on file by this date.
○ April 12, 2011	After registering for summer classes, students must complete the Summer Financial Aid Application available at <a href="http://www.berklee.edu/forms">www.berklee.edu/forms</a>
○ April 18, 2011	Summer 2011 semester bills are mailed
○ May 13, 2011	Payment due to the Bursar for summer semester charges. Late payment will result in a \$250 fee.
○ June 10, 2011	First round of refund checks issued for the summer semester
○ August 1, 2011	Students graduating in August must complete Exit Interview requirements
